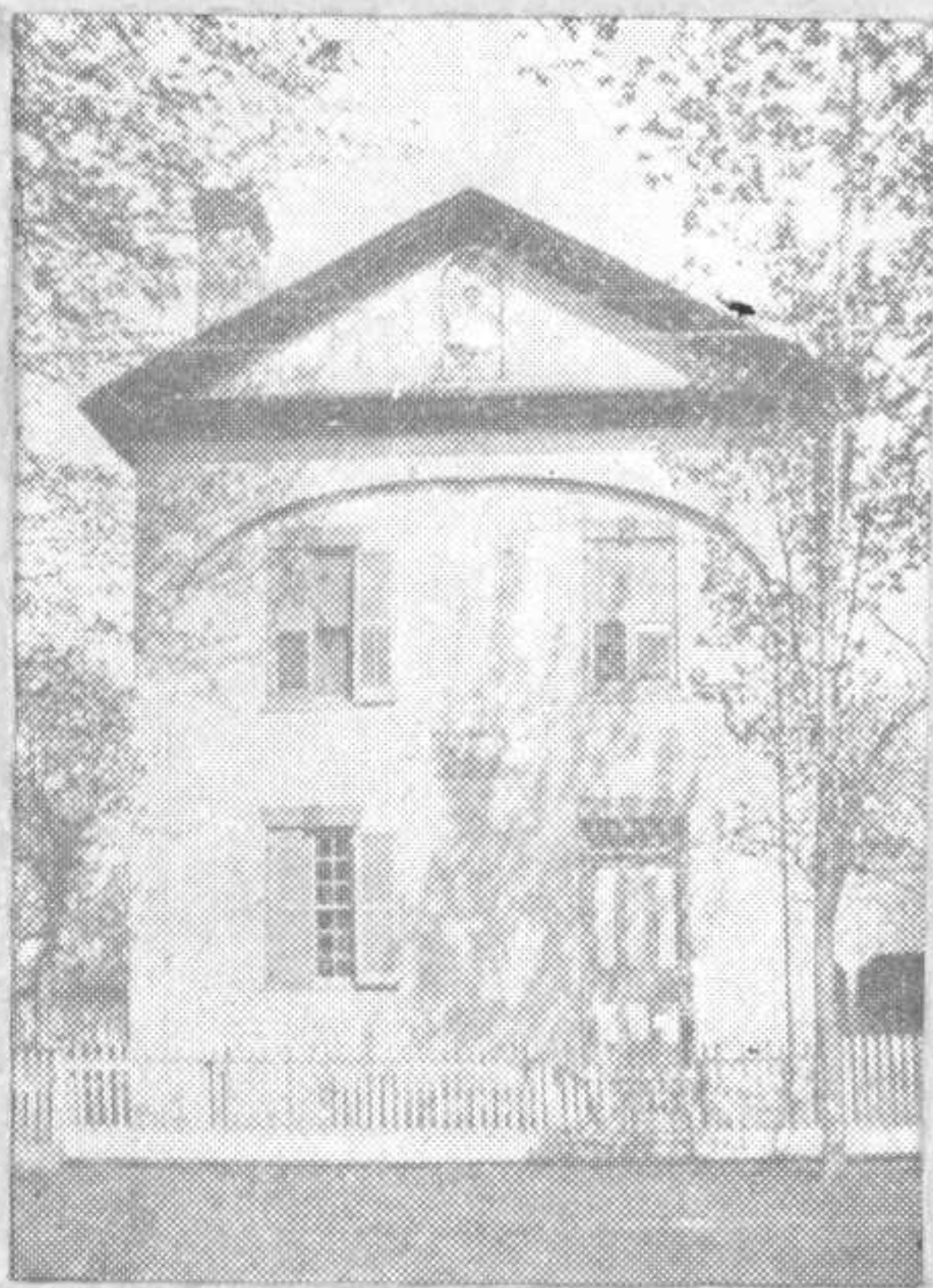

# Historical Sketch of New England Lodge No. 4, F. & A. M. of Ohio

New England Lodge No. 4, under the jurisdiction of the Most Worshipful Grand Lodge of the Ancient and Honorable Fraternity of Free and Accepted Masons of the State of Ohio, was originally constituted as No. 48 by virtue of a charter issued by the Grand Lodge of Connecticut, (as I am informed by the Grand Secretary of that Grand Lodge) at the half yearly communication October 19, 1803, to sundry brethren who had formed a settlement on the River Scioto, State of Ohio. The Lodge to be holden in the town of Worthington: Worshipful and Reverend Bro. James Kilbourne to be the first Master.

The Lodge continued to work under this charter until the convention called to meet at Chillicothe on the first Monday of January, 1808, to form a Grand Lodge. The Lodge was represented by its Master, James Klbourne.

At this convention there were delegates from six lodges. No. 1 American Union at Marietta, originally chartered as a military Lodge, but at the end of the Revolutionary war this Lodge was disbanded, but the Master kept the warrant and a Lodge was organized in Marietta in 1791, which afterwards received a charter from the Grand Lodge of Massachusetts.

No. 2 was Cincinnati Lodge, holding a warrant from the Grand Lodge of Kentucky, granted in 1806. This Lodge was formed by a portion of a Lodge chartered by the Grand Lodge of New Jersey in 1790 by the name of Nova Ceserea, which charter had been surrendered in 1805 but irregularly, and in 1813 the two branches were consolidated by the name of Nova Ceserea Harmony.

Erie Lodge of Warren No. 3, holding a charter of the same date of that of this

Lodge from the Grand Lodge of Connecticut, Scioto Lodge at Chillicothe, chartered by the Grand Lodge of Massachusetts in 1805, Amity Lodge of Zanesville, chartered by the Grand Lodge of Pennsylvania in June, 1805, and our own Lodge.

The Committee on Credentials decided that the credentials of the delegates from New England Lodge were not regular and refused them seats in the convention. No reason appears in the records of the convention but the records of the Lodge disclose that the delegates were chosen at a called meeting of the Lodge, but do not show that notice of the meeting had been given to the members. As this was the cause of the rejection of the credentials of the delegates.

At the first meeting of the Grand Lodge held on January 2, 1809, the Lodge was requested to join with the other Lodges in the Grand Lodge, and to send its representatives to the next annual communication.

At the next annual communication in 1810 the Lodge was represented by its Master, James Kilbourne, who was elected Junior Grand Warden, to which office he was re-elected in 1811.

The Lodge was represented at the Grand Lodge under its Connecticut charter until the annual communication of 1814, when it had 35 Master Masons and one Fellow Craft as members, when it received a charter from the Grand Lodge of Ohio, with the following brethren as charter members: J. H. Hillis, Jacob Norton, C. Barker, J. Kilbourne, Aaron Strong, Wm. Robe, J. Goodrich and Chas. Thompson.

The officers for the year 1814 were W. M., J. H. Hills; S. W., Jacob Norton; J. W., C. Barker; Treasurer, Joel Buttles; Secretary, Wm. Robe; S. D., Cruger Wright; J. D., Chester Pinney; Steward Tyler, Abel Cross, with the following members: James Kilbourne, Stephen Maynard, John Goodrich, Israel Wilson, Aaron Strong, Lincoln Goodale, Isaac Griswold, Noah Andrews, Ebenezer Goodrich, Roswell Tuller, S. C. Humphrey, Samuel Sloper, Chas. Thompson, Ethan Palmer, E. Loddington, Job W. Case, Calvin H. Case, Samuel H. Maynard, Hector Kilbourne, John Moore, Samuel Shannon

and O. Benedict, Master Masons, and Peter Barker, a Fellow Craft.

In 1813, James Kilbourne was elected Deputy Grand Master, and re-elected in 1814.

In 1815 Chester Griswold was elected Junior Grand Warden, and in 1816 and \*\*\*\* he was elected Senior Grand Warden and Grand Lecturer, and in 1818 he was elected Grand Master, and John Snow was elected Senior Grand Warden and Lecturer.

In 1819 John Snow, who was then Master of this Lodge, was elected Grand Master, and held that office until the session of 1824, and was again elected and served one year in 1829.

In 1820 the present brick Lodge building was erected on a lot owned by John Snow, who in April, 1824, for the consideration of \$95.00, executed a deed conveying the lot with its appurtenances to Jeremiah Morrow, as Governor of the State of Ohio, and his successors, to hold the same for the use of the Lodge and Horeb Chapter, for the uses and purposes named forever.

The Lodge continued to work through the Anti-Masonic trouble, and was represented at every annual communication of the Grand Lodge except 1833 to 1876, although by reason of the persecution the number of members was reduced to 19 in 1847. In fact the Lodge has been represented at every session of the Grand Lodge except in the years 1833, 1876, 1893 and 1897. During the period of the greatest agitation the brethren did not dare to hold their meetings in the building, but followed the example of our ancient brethren and held their meetings in the ravine near Chaseland, the better to observe the approach of cowans and evesdroppers.

One cause for the reduction in membership was the withdrawal in 1815 of a number of members to assist in the formation of Ohio Lodge No. 30, now Columbus Lodge. Among these brethren was Lincoln Goodale, who served as Grand Treasurer from 1818 to 1837.

In the years 1829 and 1830 the annual communications of the Grand Lodge were held in the Lodge building in Worthington.

For five years from 1838 to 1843, John Barney, Master of the Lodge, served as Grand Lecturer. The following brethren

have served as Masters since the Lodge was formed:

James Kilbourne, 1803-1812; Chester Griswold, 1813 and 1815; James H. Hills, 1814; A. Buttles, 1816; John Snow, 1817 to 1821; James Pearce, 1822; Daniel Upson, 1823; Ira Metcalf, 1824; R. R. Chapman, 1825 to 1826; John Snow, 1827-1830; Ira Metcalf, 1831-1833; James Kilbourne, 1834-1835; Ira Metcalf, 1836; John Barney, 1837-1844; Geo. Taylor, 1845-1846; A. Bacon, 1847-1855; Geo. Taylor, 1856-1867; Wm. T. Snow, 1868; H. W. Wright, 1869-1870; J. R. Toppin, 1871-1872; H. W. Wright, 1873-1875; T. B. Asbury, 1876-1877; S. S. Pinney, 1878-1880 and 1882-1883; N. E. Stickney, 1881; Justin Pinney, 1884-1885; E. H. Mason, 1886-1887; H. C. Tipton, 1888; J. F. Pinney, 1889; D. W. Wright, November, 1890-April 1891; H. W. Wright, August, 1891-1893; F. F. Tuller, May-November, 1894; O. W. Aldrich to November, 1898. The brethren in the order following for one year each: R. M. Weaver, E. T. Tuller, E. O. Ackerman, C. E. Webster, H. J. Leasure, H. A. Coe, J. P. Waldorf, H. A. Evans, C. R. Slyh, C. M. Woolward, C. E. Marshall, W. R. Aldrich, W. B. Childers, G. W. Brown, Max H. C. Hirsch, W. S. Dunn and H. A. Evans.

In 1891 the Lodge numbered about 75 members, and dissatisfaction having arisen over an edict of the Grand Lodge declaring a seceding body from the Northern Jurisdiction of the Scottish Rite Clandestine, in April of that year a resolution was adopted declaring that the Lodge renounced its allegiance to the Grand Lodge and would act as an independent Lodge, which was signed by all but about 9 or 10 of the members. Thereupon, Grand Master Levi C. Goodale arrested the charter of the Lodge, and suspended the membership from the rights and privileges of Masonry.

Nine of the brethren having declared their allegiance to the Grand Lodge, he issued a dispensation empowering them to act until the following annual communication of the Grand Lodge, and at that communication in October, 1891, a substitute charter was issued to the loyal members by the name and number of the Lodge, with the rank and precedence of the Lodge as formerly chartered.

The brethren named in the new charter were D. C. Brand, G. W. Foster, C. S. Fay, F. F. Tueller, S. W., and G. W. Foster, J. W. H. W. Wright, Thomas Wiley and F. H. Wright. Bro. H. W. Wright was Master, F. F. Tueller, S. W., and G. W. Foster, J. W. This charter is the one under which we are now working. The seceders being in the majority, retained possession of the Lodge building, furniture, library, records and the old charter of 1814, and there being no good place of meeting, the Lodge met only a few times each year until the spring of 1894. H. W. Wright having died and a few other brethren having been reinstated by the Grand Master, a dispensation was granted in April, 1894, to elect new officers, and in May F. F. Tuller was elected W. M., O. W. Aldrich, S. W. and R. M. Weaver J. W.

From this time the Lodge has continued to meet regularly, and has been represented at every meeting of the Grand Lodge, except the one in 1897.

In the fall of 1899, Horeb Chapter having released its rights in the Lodge building to the Lodge, a memorial was presented to Hon. Asa H. Bushnell, Governor of the State, asking him as the holder of the legal title, either to take action at law as trustee to oust the seceding Lodge from the building, or to make a deed conveying it to Bro. R. M. Weaver as trustee for the Lodge. And the governor executed a deed to Bro. Weaver as requested.

An action was begun by the seceding members, claiming to be the beneficiaries under the Snow deed, to cancel and set aside the deed and the case was decided by the Court of Common Pleas in favor of the seceding members, and on appeal to the Circuit Court the seceding members asked for a special Court, consisting of non-Masonic judges, and upon the trial it was decided that the loyal members were the proper beneficiaries under the deed made by John Snow to the Governor, and had the right to have the deed made to their trustee, and that the seceders had no claim upon the property, and in June, 1907, the supreme court unanimously affirmed the decision in favor of this Lodge, and in September the seceding Lodge, which had

been declared clandestine by the Grand Lodge, surrendered the property, and at the first meeting in October, 1907, the Lodge held its first meeting in the old building since the secession in April, 1891.

During the ten years of litigation I had the honor of representing the Lodge as its counsel, and during part of the time was ably assisted by Past Grand Master Allen Andrews, who represented the Grand Lodge.

Besides the brethren who have been honored in the Grand Lodge, a number of the brethren have held important positions in other Masonic bodies.

Chester Griswold held the office of Deputy Grand High Priest in the Grand Chapter of Royal Arch Masons of Ohio.

In March, 1818, John Snow, a member of St. John's Encampment of Knights Templar at Providence, R. I.; Thomas Smith Webb, who had been Grand Master of the Grand Lodge of Rhode Island for two years, Grand High Priest of the Grand Chapter of Rhode Island for twelve years, Grand Master of the Grand Commandery, then called Grand Encampment of Knights Templar of Massachusetts and Rhode Island for twelve years, and at that time Deputy General Grand Master of the Grand Encampment of the United States, and Frederick A. Curtis, a Sir Knight from Ireland, formed a Commandery of Knights Templar, which received a charter from the Grand Encampment of the United States on January 20, 1820, to be called Mt. Vernon Encampment with rank and precedence from June 6, 1818, and John Snow was the commander of this body from its institution until 1830. He was also elected High Priest of Horeb Chapter in 1818 and remained in that office until 1822. He was also General Grand Generalissimo of the Knights Templar in 1820, and a number of years thereafter.

At the time of the formation of Mt. Vernon Commandery in 1818, Thomas Smith Webb became a member of this Lodge by affiliation, and remained a member until his death in 1819.

William T. Snow, who was Master of the Lodge in 1868, was the son of John Snow, who served as Master from 1827 to 1837, and as Past Master in 1909 I had the unusual

privilege of installing my son, W. R. Aldrich, as Master of the Lodge over which I had presided from 1894 to 1898.

In conclusion let me say that the investigation I have made shows that while New England Lodge is No. 4 by reason of the date of its original charter, it is the oldest body in continued existence in the State, as No. 2 surrendered their charter from New Jersey in 1805 and received a new one from Kentucky in 1806.

American Union Lodge, which sent delegates to the convention to form the Grand Lodge, refused to become a part of the Grand Lodge and was declared clandestine in 1815, and in 1816 the present Lodge was chartered, its members consisting of part of the old Lodge, who had withdrawn and asked for a charter from the Grand Lodge. The old Lodge, popularly called the Ichabod Nye Lodge, continued to exist for some years, and in 1817 the Grand Lodge forbade subordinate Lodges to reorganize its members as Masons, and in 1820 the Secretary of the American Union Lodge was ordered to demand the old books from Ichabod Nye Lodge. In 1821 the Grand Lodge declared that Ichabod Nye and his associates were under the jurisdiction of American Union Lodges for discipline, which seems to be the last reference to that body.

No. 1 and No. 3 suspended in 1828. No. 1 was not revived until 1837 and No. 3 until 1854.

My brethren, we have reason to be proud of membership in the oldest Lodge in Ohio, meeting as we do in the oldest Masonic building in the State.



# By-Laws

---

## ARTICLE I.

The officers of this Lodge shall consist of a Master, Senior Warden, Junior Warden, Treasurer, Secretary, Senior Deacon, Junior Deacon, and Tyler, who shall be elected annually, by ballot, at the second Stated Meeting in November, and be installed into office within sixty days therefrom. A majority of all votes cast shall be necessary for an election.

## ARTICLE II.

The Stated Meetings of this Lodge shall be held on the first and third Tuesdays of each month. The hour of assembling shall be 7:30 o'clock p. m., Central Standard Time. Special meetings may be called, as provided by Section 67 of the Code.

## ARTICLE III.

Application for initiation or membership shall be made in writing, signed by the petitioner, specifying his age, residence and occupation, and be recommended by two members of the Lodge. They shall be presented at a Stated Meeting, and if received, be referred to a committee of three members, for inquiry and report, and they shall lie over to the next or a subsequent Stated Meeting before a ballot thereon. The fee for initiation or membership shall, in all cases, accompany the petition.

## ARTICLE IV.

The fees for conferring the degree shall be Fifty Dollars, divided as follows: Twenty Dollars for the Entered Apprentice, Fifteen Dollars for the Fellow Craft, and Fifteen Dollars for the Master Mason degree. The fee for membership on demit shall be One Dollar. A unanimous vote must be had in favor of the applicant for each degree, or for admission to membership, and in no case shall a ballot be taken until the money required for the fee shall be in actual deposit.

## ARTICLE V.

After a petition has been received and noted upon the minutes, it shall not be withdrawn without the consent of three-fourths of the members present, but it can not be withdrawn after the report of the committee thereon. If only one black ball appears a second ballot shall be taken immediately, but in no case shall a third ballot be had.

## ARTICLE VI.

Every candidate for passing or raising shall, before the degree is conferred, be examined in open lodge, in the degree already taken, and shall be found to possess a competent knowledge of that degree before he progresses. After the Master Mason degree is conferred upon the candidate, he shall learn and be examined upon the lecture of that degree within a reasonable time.

## ARTICLE VII.

Each member shall pay annually the sum of Three Dollars into the funds of the Lodge, at or before the Stated Meeting for the election of officers for the ensuing year.

## ARTICLE VIII.

The Master shall cause the Secretary to enter "Suspended" every member who shall be in arrears for dues six months after the time fixed for payment- and if his dues are not paid within three months thereafter, he may be expelled; and in default of such payment, charges shall be preferred against such delinquent member, and proceedings had in accordance with the provisions of the Code.

## ARTICLE IX.

Any member in good standing and not in arrears for dues, shall be entitled to a Diploma on proper application and on payment to the Secretary of One Dollar for use of the Lodge.

## ARTICLE X.

The Master and Wardens shall be ex-officio, a Committee of Charity, and have

power during recess of the Lodge, to draw orders on the treasury for any sum not exceeding Three Dollars for the relief of any one applicant.

#### ARTICLE XI.

No Masonic punishment shall be inflicted upon a brother except suspension for non-payment of dues, unless it be upon written charges and specifications made and presented to the Lodge, in the manner prescribed in the Code, and the Secretary shall furnish the accused brother a copy of such charges and specifications, and the proceedings thereon and trial shall in all respects be conducted in conformity to the Code.

#### ARTICLE XII.

The Master shall, at the time of his installation, appoint a standing committee of three members of the Lodge, whose duty it shall be to take cognizance of the conduct of brethren within the jurisdiction of the Lodge, reconcile difficulties that may arise among the brethren, and when proper, prefer charges and specifications in conformity to the Code.

#### ARTICLE XIII.

When the Lodge is open, unless the Master shall otherwise direct, the following order of business may be observed:

1. Reading of the minutes.
2. Reading and referring petitions.
3. Receiving reports of committees.
4. Balloting for candidates or for admission.
5. Conferring degrees.
6. Receiving and considering resolutions.
7. Considering unfinished business.
8. Disposing of such other business as may lawfully come before the Lodge.

#### ARTICLE XVI.

Every candidate raised in this Lodge shall before he becomes a member, sign these By-Laws; and every candidate for membership by demit shall personally or through the Secretary of the Lodge sub-

scribe to these By-Laws before he shall become a member.

#### ARTICLE XV.

No alteration or amendment of these By-Laws shall be made unless the same be proposed in writing at a Stated Meeting, when it shall be entered upon the minutes and lie over until the next Stated Meeting, when it shall require the sanction of three-fourths of the members present and unless the amendment be an alteration of the times of the Stated Meetings of the Lodge or of the amount of the annual dues, it shall further require the approval of the Grand Lodge or Grand Master for its adoption.
