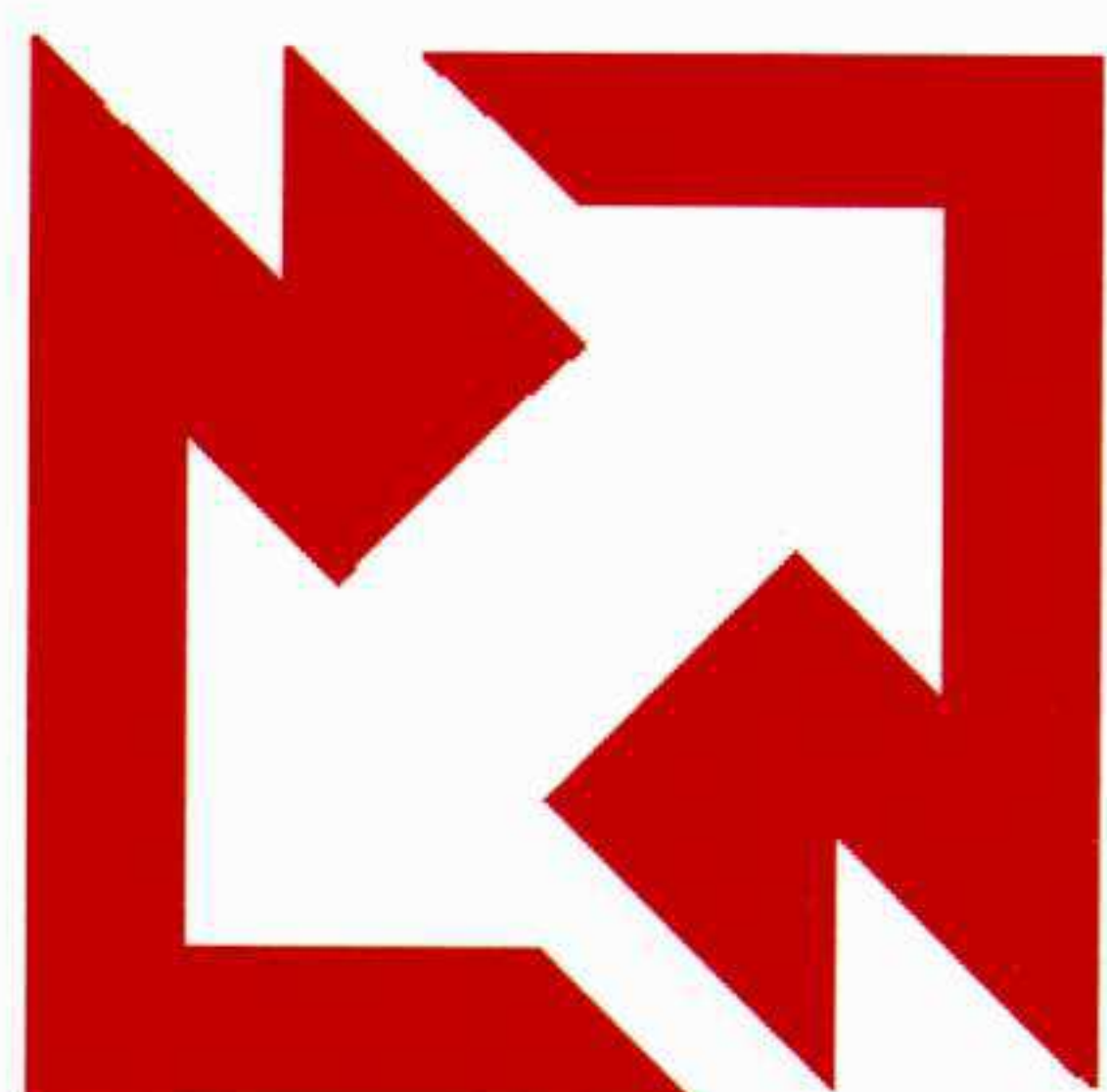

Leadership Worthington Program Goals

- To identify and motivate present and potential Worthington-area leaders.
- To help participants understand and develop leadership styles and skills.
- To guide participants to examine the implications of leadership.
- To offer processes and options for dealing with organizational needs.
- To facilitate networking among present and potential Worthington-area leaders.

Leadership Worthington

The concept of a community leadership academy originated in Atlanta in the early 1970s and spread to other areas where communities sought to foster leadership and development.

Following the successful examples of metropolitan leadership academies, but seeking an identity uniquely tailored to the Worthington area, Leadership Worthington was launched in late 1989.

It began as a cooperative venture of Worthington Schools/Business/Community Partnership Council and the Worthington Area Chamber of Commerce, under the coordination of Lynn Straker (from 1989 to Fall 1990) and Kathy Moore (Fall 1990 to Fall 1991). Janey Davies was hired as Leadership Worthington coordinator for the 1991-92 program.

A charter board of 30 trustees, representing the diverse businesses and interests of the Worthington area, established goals and guidelines, seminar curriculum, candidate selection criteria, and this program mission:

Leadership Worthington seeks to identify individuals from all sectors of the community and inspire in them an appreciation of our past, our present and our potential. Its mission is to expand the horizons of today's leaders and to provide opportunity and training for tomorrow's leaders. Only by fully developing our human resources can we expect the community to grow and prosper for the benefit of all.

Leadership Worthington graduated its charter class of 25 persons in June 1991. These emerging community leaders — many already well established as volunteers, mentors and officers of community organizations — are pictured within this directory.
